Professor G. Biswas and the MHRD officials could not attend the meeting due to unavoidable reasons. The IFD, MHRD has however sent its observation on the agenda items of the meeting.

Due to lack of quorum the meeting was adjourned. The adjourned meeting was resumed at 5.30pm as there were some very urgent items to be discussed by the Board.

At the outset the Director, NIT Meghalaya, the Acting Chairman welcomed the members to the XIIIth meeting and appraised the members on the expiry of term of the 1st Chairman of the Board, Professor D. K. Basu.

All the members of the Board expressed their greatest appreciation of the enormous contribution made by Professor D. K. Basu from the very start of the Institute as the Chairman of the Board of Governors and requested the Director to communicate the same to Professor Basu.

The agenda of the day was then taken up.

<u>Item No. 1:</u> Confirmation of the Minutes of the XIIth Meeting of the Board of Governors of the Institute held on 30.03.2016.

The XIIth meeting of the Board of Governors of NIT Meghalaya was held on 30.03.2016 in the Conference Room of the Institute. The minutes of the meeting were circulated amongst the members of the Committee for their comments/ observations. No comments/ observations were received from the members.

The Board decided to confirm the minutes as circulated.

<u>R1/BOG/XIII/2016</u>: The Board **RESOLVED** to **CONFIRM** the Minutes of the XIIth Meeting of the Board of Governors of NIT Meghalaya held on 30th March, 2016 as circulated.

<u>Item No. 2:</u> Follow up action on the decisions of the Board of Governors of NIT Meghalaya taken on its XIIth meeting.

The actions taken on the resolutions of the Board in its XIIth meeting were circulated among the members were elaborated by the Director.

On the resolution **R4.2/BOG/XII/2016,** the Board was intimated by the Director on- (i) intimation by the MHRD for compliance of the existing notification of the Ministry No. F.21-35/2009.TS-III dated 23.06.2009 regarding waiver of Tuition Fee for SC/ST PG students and Doctoral scholars, (ii) expected notification from the Ministry regarding the waiver of tuition fees to B. Tech students of NITs from SC/ST Categories and from economically weaker families in the lines of the IITs.

R2/BOG/XIII/2016: The Board **NOTED** the actions taken on the resolutions of the Board in its XIIth meeting. The Board further **RESOLVED** the following:

- i. Waive the Tuition Fees for the SC/ST students and SC/ST scholars of the PG and Doctoral programs.
- ii. **AUTHORIZE** the Director to implement the changes in the tuition fee and waivers as directed by the Ministry.

Item No. 3: Institute Rank under NIRF

The Board was intimated that the Institute secured the 57^{th} position among the 1438 engineering institutions that participated in the ranking. The Institute topped the 11 new NITs and came 15^{th} among the 31 NITs.

The Board expressed happiness on the performance of the Institute in the ranking. It deliberated on the marks received by the Institute under the various criteria and advised that the Institute works on the aspects in which it is found to be lacking.

R3/BOG/XIII/2016: The Board expressed happiness on the performance of the Institute in the ranking. It advised that the Institute works on the aspects in which it is found to be lacking.

Item No. 4: Additional Land Received from the Govt. of Meghalaya

The Govt. of Meghalaya has handed over additional plots of land adjacent to the existing plot for the permanent campus totaling about 106 acres. Including these additional plots the total area for the permanent campus now becomes 326 acres. The Director elaborated on the details of the new plots received and mentioned that a tender has already been floated for the topographic survey of the plots and initiative shall also be taken for construction of the boundary walls soon.

R4/BOG/XIII/2016: The Board expressed happiness over the receipt of additional plots of land from the State Government and asked the Director to do the needful for its incorporation in the Master Plan of the Institute Campus.

As the institute is new and the batch sizes are small, it is not appropriate to decide on faculty positions based on the actual student strength. Therefore, the Board had created 66 faculty positions based on sanctioned student strength for 2015-16. On the same ground it is proposed that an additional 12 (twelve) positions be created for a total of 78 (seventy eight) faculty positions for the year 2016-17. These additional positions will be used for Ad hoc/ Consolidated Pay appointments till concurrence for the additional positions is received from the ministry.

R6/BOG/XIII/2016: In exercise of the provision in clause 13(2)(d) of the NITSER ACT 2007, the Board **RESOLVED** to **APPROVE** the creation of the additional 12(twelve) positions for a total of 78 (seventy eight) faculty positions, with the additional positions in excess of those sanctioned by MHRD to be used only for engagement of faculty under Ad hoc/Consolidated Pay appointments.

Candidates were asked to fill-in the online application forms by 24.12.2015 and the hard copies were to reach the Institute on or before 31.12.2015.

Item No. 8: Detailed Project Report (DPR) 2016 of NIT Meghalaya

The DPR preparation committee constituted by the Board has submitted its final report. However the Ministry in a meeting held on 1st June advised for preparation of the DPR in new format and asked for projection of the expenditure up to 2030, in a phased manner. The Ministry requested for submission of the DPR to the ministry by 31st July. The Board was appraised that the Institute has involved the Architect Consultant of the Institute to fill-in the necessary details for the DPR in the revised format so that it can be made ready within the stipulated time. Further, a projection of the academic programmes and the student strength and the human resource plan till 2030 were placed before the Board for its approval.

R8/BOG/XIII/2016: The Board **NOTED** the development and **APPROVED** the projected academic programmes and the student strength and the human resource plan for the Institute till 2030 (**Annexure-III**). The Board further suggested that the approval of the Board for the New DPR recommended by the Committee may be made through circulation.

Item 9: Enhancement in rate of DA

Office Memorandum dated 7th April, 2016 No. 1/1/2016-E-II(B) issued by the Ministry of Finance, Dept. of Expenditure for payment of Dearness Allowance to Central Govt. employees with revision of rates effective from 01.01. 2016 enhanced the rates from 119% to 125%.

Chairman, Board of Governors approved the adopting of the enhanced rates for the employees in the institute, subject to ratification by the Board. The Board may consider ratifying the approval.

R9/BOG/XIII/2016: The Board **RESOLVED** to **RATIFY** the approval given by the Chairman for adoption of the enhanced DA rates.

Item 10: Addendum to the SAR on the accounts of the Institute

The AG office, Shillong had sent an addendum to the Separate Audit Report (SAR) on the accounts of the Institute for the year 2015-16 revising an observation under "Adequacy of Internal Control System". A copy of the same was circulated along with the agenda items for perusal by the members.

In the original SAR it was observed-

"Actuarial valuation of the liability payable towards gratuity, superannuation/pension and accumulated leave encashment as on 31 March 2015 was not done"

The AG has now revised this observation as-

"The liability of Retirement Benefits of the Institute have not been provided on actuarial basis in contravention of AS-15."

<u>R10/BOG/XIII/2016</u>: The Board **RESOLVED** that an Actuary be consulted to incorporate the liability of the Institute due to the Retirement Benefits from the FY 2016-17 to comply with the requirements.

Additional Items:

Item No 11: Engagement of Faculty under DST INSPIRE Faculty Program

The Department of Chemistry was in need of a faculty position in Inorganic Chemistry. However the Institute was not in position to provide a position for the purpose. The Department proposed that a faculty member in the area be engaged under the INSPIRE Faculty program of the Department of Science & Technology (DST), GoI in which DST provides the salary for a period of five years @ Rs. 80,000/- pm and also provides a sum of Rs. 35 lakhs for setting-up of laboratory facilities for the research work of the faculty member. An advertisement was placed in the Institute website seeking application from persons having received INSPIRE Faculty award from DST in Inorganic Chemistry. Two applications were received. One of the applicant's area was not inorganic chemistry. The other applicant Dr. Mukul Pradhan was from inorganic chemistry. He was invited to make a presentation on his work and have an interaction with the department faculty. The same was done in the month of April and the department found him suitable and recommended for his engagement. The Director accepted the recommendation of the department and offered a faculty position to Dr. Pradhan under the INSPIRE program of DST. The Board was also informed that Dr. Pradhan joined duty on 12th May, 2016.

R11/BOG/XIII/2016: The Board **NOTED** the engagement of Dr. Mukul Pradhan as a DST INSPIRE Faculty in the Department of Chemistry.

Item No 12: Purchase of an Ambulance for the Institute

An approval of the Ministry was received for the purchase of an Ambulance vide order No F.No.21-3/2012.TS.III dated 29th May 2015. But, in its Xth meeting held on 14.09.2015, the Board of Governors decided (Resolution No. **R8.1/BoG/X/2015)** to defer the purchase of an Ambulance till the Institute shifts to the permanent campus in Cherrapunjee. However, due to occurrence of emergency cases at night in Bamboo Huts Boys Hostel when no vehicles were

available to take the students to Hospitals, it was then felt necessary to purchase an Ambulance immediately. In this connection, a committee for procurement of the Ambulance was formed which constituted of the following members:

- a) Dr. D. K. Sarma, HoD, Mechanical Engineering Chairman
- b) Dr. S. Mukherjee, Associate Dean (Students Welfare) Member
- c) Mr. B. Blahwar, Assistant Registrar (Estt.) Member
- d) Mr. A. Bhattacharjee, Comp. Sc. and Engineering Convener

The committee collected quotations from different showrooms/ dealers/ distributors located at Shillong. Based on the space constraints for carrying Ventilation Unit (ICU Van), seating capacity, etc. of different vehicles keeping in mind the future requirements of the Institute, the Committee opted for the following two vehicles:-

- a) Traveler of Force Motors
- b) Winger of Tata Motors

After comparison of technical specifications of the above mentioned vehicles, the Committee recommended for purchase of **Traveler Ambulance 3350WB BS IV** (ABS) Fully Fabricated of Force Motors at an amount of Rs.16,92,080/-. The Board is requested to consider approving the same.

R12/BOG/XIII/2016: The Board **RESOLVED** to **APPROVE** purchase of the Ambulance as recommended by the Committee.

<u>Item No. 13</u>:Conversion of sanctioned position of Sports Officer to a position of Assistant Registrar.

The Ministry of Human Resource Development vide its Letter No. F.24-2/2010-TS.III dated 13.10.2011 had sanctioned one position of Sports Officer in PB-3 (Rs.15,600 - 39,100) GP of Rs. 6,000/- for NIT Meghalaya. The Institute being in its nascent stage without its own elaborate sports and games facilities, it was felt that recruiting a Sports Officer at such an early stage will not be helpful.

With the student and staff strength increasing every year, the work load in both the Academics and Accounts Sections has increased manifold. Therefore, to take on the responsibilities and to carry the Institute forward during these initial stages, the need for Assistant Registrars on a regular basis is more important than a Sports Officer.

It is therefore proposed that the latter position be converted to a regular position of Assistant Registrar in PB-3 (Rs.15,600- 39,100) GP of Rs. 5,400/- with all other applicable allowances and benefits as with other employees of the Institute. Subsequently, when the Institute shifts to the permanent campus with all facilities and when sanctions come, one position of Assistant Registrar will be reverted back to the position of Sports Officer.

The Board was requested to consider and approve the proposal of conversion of the post as described above.

R13/BOG/XIII/2016: The Board **RESOLVED** to **APPROVE** conversion of the position of Sports Officer to a position of Assistant Registrar.

<u>Item No. 14</u>: Daily rates for accommodation and food bill of Trainee Teachers when attending conferences, workshops etc.

It was noticed that the Trainee Teacher 2014 batches had been applying for Financial Assistance to enable them to participate in various conferences in regard to their research work. Till date, only 4 (four) Trainee Teachers have applied for financial assistance but so far they have not claimed for any TA & DA except for flight/ train fare, registration fees and abroad DA which was reimbursed in full.

The maximum Contingency/ Professional fund for the year 2016-17 is Rs. 49,890/- However, there is no clear indication as to how much TA & DA is admissible to them as per the Trainee Teacher Scheme.

As such the Director had fixed the following as daily rates for accommodation and food bill for Trainee Teachers when they attend conferences, workshops, etc. within India:-

- 1. Accommodation @ Rs. 1500/- (Rupees one thousand five hundred) only per day
- 2. Food bill @ Rs. 300/- (Rupees five hundred) only per day

It was also decided that the DA rates for attending conferences, workshops etc abroad will be as per rules notified by the Govt. of India from time to time.

Reimbursements will be made up to the ceiling daily rates above, subject to the maximum available contingency/ professional fund for the particular year (i.e. July of a year to June of the following year). Any expenditure incurred over and above the ceiling rates or maximum available contingency/ professional fund shall be borne by the Trainee Teacher him/herself.

The Board was requested to consider and approve the daily rates for accommodation and food bill of Trainee Teachers when attending conferences, workshops etc. as mentioned above. The Board was informed as the Trainee Teacher scheme is new no other CFTI has adopted such rates so far.

The Board deliberated on the matter. Since the amount that can be paid to a Trainee Teacher for the purposes is within the ceiling of Rs. 49,890/- in a year under the contingency head and the rates quoted are below that for a faculty member, the Board decided to approve the rates.

R14/BOG/XIII/2016: The Board **RESOLVED** to **APPROVE** the daily rates for accommodation and food bill for Trainee Teachers when they attend conferences, workshops, etc. within India as Rs. 1500/- and Rs. 300/- respectively per day payable from within the contingency head.

Item No. 15: Resignation of Mr. S. Arun, Dept. of Mechanical Engineering

Mr. S. Arun, Asst. Professor (on Consolidated Pay) in the Dept. of Mechanical Engineering, has tendered his resignation vide his letter dated 15.03.2016 in order to join a position of Scientist at CSIR-National Aerospace Laboratory, Bangalore. As per his offer of appointment, he is to give one month's notice for terminating the engagement. His resignation was accepted by the Director subject to the ratification of BOG. He was released from the Institute on 08.04.2016(AN).

The Board was requested to consider and approve the release of Mr. S. Arun as mentioned above.
