Shri Sharma attended the meeting through Skype. The IFD, MHRD however sent its observations on the agenda items of the meeting.

At the outset the Director, NIT Meghalaya, the Acting Chairman welcomed the members to the XVth meeting and the agenda of the day was then taken up. However, due to power failure at the ministry office Shri Sharma's Skype link got disconnected and the meeting had to be adjourned due to lack of quorum.

As there were some urgent items in the agenda to be discussed the adjourned meeting was resumed after a wait of half an hour.

<u>Item No. 1</u>: Confirmation of the Minutes of the XIVth Meeting of the Board of Governors of the Institute held on 28.07.2016.

The XIVth meeting of the Board of Governors of the NIT Meghalaya was held on 28.07.2016 in the Conference Room of the Institute. The minutes of the meeting were circulated amongst the members of the Committee for their comments/ observations. Observations were received from the ministry on the minutes and the remarks of the Institute against these observations were circulated along with the agenda items.

Item No. 4: Annual Report and Audited Annual Accounts

The draft Annual Report for 2015-16 of the Institute was circulated along with the agenda items of the meeting for consideration and approval by the Board. The Board was intimated that the Annual Audit of the Accounts for FY 2015-16 was completed by the Office of the AG, Shillong and there were not major observations. The final report of the audit which was expected before the meeting was however not received.

The Board approved the draft Annual Report with minor corrections asked that approval for the Audit Report be taken through circulation before sending for printing.

<u>R4/BOG/XV/2016</u>: The Board **Resolved** to **Approve** the Draft Annual Report of the Institute for the year 2015-16 and asked that the approval for the Audit Report be taken through circulation among the members.

Item No. 5: Appointment of a Registrar In-charge

The Institute currently does not have a Registrar as Mr. D. J. Goswami reverted to his parent organization. The Director himself was acting as the DDO. The position of Registrar was advertised and the screening of the applications has also been completed. However, as the term of the Director was coming to an end as per standing instruction of the Ministry the selection of the Registrar could not be carried out. To enable routine transactions it is necessary to appoint a Registrar In-charge. The Committee of Deans has made a recommendation to appoint Dr. Deba Kumar Sarma, Associate Dean (Planning and Development) as the Registrar In-charge.

The Board discussed the matter and decided to approve appoint Dr. Deba Kumar Sarma as the Registrar In-charge until further order or till a regular Registrar joins, whichever is earlier. Dr. Sarma will be receiving a charge allowance of Rs. 3,500/- pm.

<u>R5/BOG/XV/2016</u>: The Board **Resolved** to **Approve** appointment of Dr. Deba Kumar Sarma as the **Registrar In-charge** with a charge allowance of Rs. 3,500/- pm.

Item No. 6: Expiry of Term of the Director

The Board was aware that the term of the Director Prof. D. K. Saikia is expiring on 31st October, 2016. As his leave from parent organization, Tezpur University, will also expire on 31st, he will have to relinquish his charge as Director, NIT Meghalaya and join back the parent university on 1st November.

The process of selection of the next regular Director for the institute has been taken-up by the Ministry. However, a gap between the expiry of term of the current Director and the taking over of charge by the next regular Director is very likely. As there is no senior faculty member, at the level of professor, in the institute, the Director of one of the NITs/IITs is likely to be given the charge. The Ministry is required to notify who should be officiating as the Director.

It was decided that the Registrar in-charge shall exercise the powers as delegated to the Registrar vide BoG resolution no. R8/BOG-III/2013 including that of DDO, except that, the Cheque Signing shall be done jointly by the Registrar in-charge and the Assistant Registrar (Establishment).

For the interim period till the regular Director joins the Institute, the Associate Deans shall have power of sanctioning of urgent expenditures up to Rs. 25,000/- in their respective domains of activities and the Registrar in-charge shall have power of sanctioning up to Rs. 25,000/- for administrative activities. The Registrar in-charge shall have power of releasing payments as follows:

- 1. Release of payments of monthly salary, scholarships, transport bills, rents, electricity, telephone and postal bills.
- 2. Release of bills of approved works/ purchases up to Rs. 10,00,000/-, duly certified.

For any requirement beyond the above limits shall require the approval of the Director incharge. Any sanctions made by the Assoc. Deans and the Registrar in-charge shall be reported to the Director in-charge during his next visit.

Due to the resignation of the Junior Engineer (Civil) in the Engineering Section the position was vacant and the Executive Engineer was very much handicapped. The position was advertised in August, 2016 against which 270 applications were received. After due screening 239 candidates were called for written test. Based on the written test performance 8(eight) candidates were called for personal interview held on 17th October, 2016. The duly constituted selection committee recommended appointment of Mr. Myselmon Pyngrope to the position as per rule.

The Board noted the selection process and decided to approve appointment of Mr. Myselmon Pyngrope to the post of Junior Engineer (Civil).

Item No. 9.4: Confirmation of Dr. C. Marthong, Assistant Professor, Civil Engineering

Dr. C. Marthong who was in the service of Govt. of Meghalaya joined NIT Meghalaya on lien as an Assistant Professor in Civil Engineering on 10th January, 2013 after due process of selection. He has also been placed in the grade of AGP Rs. 8000/- of the 4-tier flexible faculty

structure on the recommendation of selection committee in July, 2015 and he has been on probation since 3rd July, 2015. As such he is eligible for confirmation if he is released by the Govt. of Meghalaya from its service. However, Dr. Marthong has informed that due a bond signed by him for leave for his PhD studies the process of his release by the Govt. of Meghalaya is getting delayed.

Considering the above the Board was requested to consider his case of confirmation.

The Board discussed the matter and decided to confirm the service of Dr. C. Marthong in his position as Assistant Professor subject to receipt of his release documents from the Govt. of Meghalaya.
