## **Item No. 6**: Amendments in Ordinance VI (On Award of Scholarships)

As per Ordinance-VI of the Institute the top 5% of the students are awarded Merit Free Studentship and another 5% are awarded Merit cum Means Free Studentship. Under these Free Studentships the tuition fee of the awardees is waived. As the tuition fees in the Institute has increased substantially in the recent years the benefit due to free studentship has become significantly higher than most of the other scholarships. The Board of Governors has resolved that instead of the waiver the students be awarded scholarships and the scholarship amount be fixed at 40% of the tuition fees charged by the Institute. Accordingly, two scholarships, Merit Scholarship and Merit-cum-Means Scholarship are proposed, from the next academic year 2016-17, in place of the two Free Studentships with amendments in the Clause D of Ordinance-VI as follows:

## **D. B. Tech Scholarships:**

#### a. Merit Scholarship:

- 1. There shall be a scholarship of 40% of the tuition fee amount awarded to top 5% B. Tech students in a batch based on the CGPA achieved in the previous semester.
- 2. The scholarship shall be awarded from the 2<sup>nd</sup> semester onwards up to the 8<sup>th</sup> semester.
- 3. To be eligible the student must secure a CGPA of 8.5 or above.
- 4. A student receiving the scholarship for the entire duration of the programme starting from the 2<sup>nd</sup> semester shall be awarded a certificate of merit.

#### b. Merit cum Means Scholarship:

- 1. There shall be a scholarship of 40% of the tuition fee amount awarded to up to 5% of the B. Tech students in every batch who come under the non-creamy layer and are able to maintain a CGPA of 7.0 or above.
- 2. The scholarship shall be awarded from the 2<sup>nd</sup> semester onwards up to the 8<sup>th</sup> semester.
- 3. The list of students to be awarded the merit cum means scholarship shall be decided by a selection committee comprising the Dean of Students Welfare as the Chairman and the Heads of the Engineering Departments as its Members. The selection shall be from among the eligible candidates based on a score (S) computed as below:

 $S= 0.5 \times CGPA + 0.5 \times IS$ where,  $IS = 10 \times L/I$ , L being the lowest reported income of the eligible candidates parents/guardians and I being the parent/ guardian's income of the student concerned.

Amended Ordinance of Awards of Scholarships were placed at Annex-3

The Senate was requested to consider approving the above amendments in Ordinance-VI.

Ph.D Regulations with Form IIA & Form IIB", necessary inclusion and changes are made in the PhD regulation. Amendments required in PhD regulation were placed at Annex-4.

The Senate was requested to consider approving the above amendments in PhD regulations.

Clause 11.1 shall now be:

A Ph. D scholar may submit his/ her thesis (along with Form XII) within the stipulated period but not later than six months from the date of pre-submission seminar provided he/ she fulfills all requisites for Ph. D thesis submission with at least one peer-reviewed/ refereed publication including book chapters.

## Item No. 9: Admission: Items Approved by the Director for Ratification

## A. To keep on hold Admissions to the M. Tech Programme in Water Resource Engineering:

Professor P. S. Choudhury had to go back to his parent Institute due to personal reasons and the Institute currently lack senior faculty in the Department of Civil Engineering with specialization in Water Resource. There was also very poor response to the M. Tech programme in Water Resource Engineering during the admissions in 2015. Considering the above it was decided not to admit students to the M. Tech programme in Water Resource Engineering in 2016.

<u>**R9(A)/SENATE-VIII/16:**</u> The Senate **Resolved** to **Approve** temporary hold of admissions to the M. Tech Programme in Water Resource Engineering.

## B. Offering of one seat in each of the B. Tech disciplines under DASA:

The DASA (Direct Admission of Students Abroad) is a scheme under which NITs admit students from abroad based on SAT score over and above the sanctioned intake. So far NIT Meghalaya had not admitted students under DASA considering that the Institute is functioning from a temporary campus without sufficient infrastructure and hostel facilities and deferring it till shifting to the permanent campus. However it was thought that joining the scheme will give the Institute some international visibility. Keeping that in mind it was decided to join the scheme this year with one seat per each of the B. Tech disciplines.

The Senate was requested to consider ratifying the above decisions taken by the Director.

<u>**R9**(B)/SENATE-VIII/16</u>: The Senate **Resolved** to **Ratify** the decisions taken by the Director to offer one seat in each of the disciplines in the B. tech Programme under DASA.
