Please note the following Corrigendum-1

The bid Evaluation Criteria has been revised which is given below against the subject tender:

A. Part of the Page no. 1 of Bid Document No. GEM/2024/B/4684172 dated 23.02.2024 must be read as:

“Kindly read the NIQ document carefully before participating. It shall be deemed that submission of bid by the bidder has been done after their careful study and examination of the NIQ terms with full understanding to its implications. Any lack of information shall not in any way relieve the bidder of its responsibility to fulfil its obligations at any stage under the Bid.”

B. Point no. 29 and 29(i) of Bid Document No. GEM/2024/B/4684172 dated 23.02.2024 must be read as:

29. Compulsory Certificates, License etc. to be furnished: The bidder/tenderer shall furnish and enclose the following important documents along with the technical bid of the tender, failing to do so may result in the rejection of the quotations received without assigning any reasons (as also mentioned in Page No. 1):

29. i. OEM’s Factory License, Trademark certificate, OEM’s India Design Mark Certificate and GRIHA certificate to be enclosed.

ARAI certificate is no longer treated as mandatory, vendors may or may not submit the said certificate as per their convenience and availability, and the certification *shall not* be considered as a criterion for acceptance or rejection of bids.


C. Additional Point as per Sl. No. 32 of Bid Document No. GEM/2024/B/4684172 dated 23.02.2024 must be read as:

32. (a) In a tender, either the Indian agent on behalf of the Principal / OEM or Principal / OEM itself can bid but both cannot bid simultaneously for the same item/ product in the same tender.

(b) If an agent submits bid on behalf of the Principal / OEM, the same agent shall not submit a bid on behalf of another Principal / OEM in the same tender for the same item / product.

Note: All other terms and conditions of the tender shall remain same.

This Corrigendum-1 is to be treated as part of the original bid document and while submitting your offer, Corrigendum-1 shall also be signed and stamped along with bid document.
