1	<p>I, Dr. Kalyanashis Jana, am very much curious about the recruitment process of all the eminent institutes, i.e., IITs/NITs/CUs/IIMs, under the Department of Higher Education. Still, some of the central universities and CSIR labs update the list of candidates who apply against a specific advertisement, the list of shortlisted candidates for interviews, the list of candidates shortlisted for interviews based on caste category, and the list of not-shortlisted candidates with the reason for not selections. However, none of the most prestigious institutions, like IITs and IISc, have recently updated recruitment documents, making the recruitment procedure less transparent. As a result, I'd like to request you to provide all the information about recruitment that happened in at least the last ten years. Please provide the information of the candidates selected against the special recruitment drive procedure along with their caste information in a systematic manner. When I requested more information about the selected and nonselected candidates, it was replied that the institute could not provide the personal information of candidates. However, we would like to see the candidates' names, application numbers, positions applied for, and reasons for selection or non-selection. We are not requesting candidates' date of birth, father/mother/spouse name, bank details, or bank account password. I would like to request that all the information should be available on the institute faculty recruitment portal, e.g., Advertisement No. 1_2018_selected_non-selected_candidates_for_interviews, Advertisement No. 5_2018_selected_nonselected_candidates_for_interviews, Advertisement No. 1_2018_final_selected_candidates. We are aware some IITs provide some information in a code, such as selected candidates are CY00056, CY5000, CY6007, etc. However, these pieces of information don't show any transparency about the non-selected candidates, the reason for rejection, which could help the candidates to improve their further applications in academia, and the candidates selected based on the caste categories. I have been requesting to provide caste-based recruitment information because it has been seen in recent times that many candidates with very weak profiles get selected in eminent institutions. If these candidates are from certain reserved categories, it is constitutionally fine. As it is a constitutional right for a candidate to be recruited based on caste or EWS, but it should be clearly reported on the finalized list for everyone. The unreserved candidates also have the right to know who is selected based on reservation. Otherwise, it seems that we are cheated when we see very weak profiles selected by many prestigious institutions. On the other hand, many candidates are chosen from lobbied faculty members. Transparency on the recruitment on every cycle of rolling/special-drive/mission-mode recruitment limits such kind of biased recruitment. To avoid conflict in the recruitment process, a list of external scientific members and panel members should be provided on the institute's website page.</p>	<p>NIT Meghalaya strive to maintain high standards in the recruitment processes. However, there are often legal and ethical considerations, particularly concerning the privacy of applicants, which can limit the extent of information that can be shared publicly. The protection of personal data is paramount, and institutions must adhere to relevant regulations, including those related to data privacy.</p>


