At the outset, the Chairman, Senate of NIT Meghalaya welcomed the members and the special invitees to the twenty-fifth meeting of the Senate. Thereafter, the agenda items of the day were taken up.

### Item No.1: Confirmation of Minutes of the XXIVth Meeting of the Senate of NIT Meghalaya held on 24.03.2021

The XXIVth meeting of the Senate of the Institute was held on 24.03.2021 through a video conference as well as through offline mode due to the ongoing COVID-19 pandemic. The minutes of the meeting were circulated amongst the members of the Committee for their comments/observations. Only one comment was received from a member which was accepted by all, and the members confirmed the minutes.

R1/SENATE-XXV/21: The Senate Resolved to Confirm the minutes of the XXIVth Senate Meeting held on 24th March 2021.

### Item No.2: Action Taken Report on the Decisions of the XXIV<sup>th</sup> Meeting of the Senate

The actions taken on the decision of the XXIV<sup>th</sup> Meeting of the Senate were circulated amongst the members. During the meeting, the actions taken were elaborately explained and the Senate members noted the actions taken by the Institute. However, during discussion, the scheme of evaluations for semester wise credit structure for Ph.D scholars after registration was recommended to be revised and presented in the forthcoming Senate Meeting:

### Item No.3: Appointment of Adjunct Faculties in the Institute

For appointment of Adjunct Faculties across various departments, the recommendations of the Department Academic Committees were analysed by the ACoFAR. With the suggestion and concurrence of the Competent Authority, the following list was placed before the Senate.

The details about each of the Adjunct Faculty mentioned above were brought before the members. The Senate deliberated on the matter at length including the first phase of appointment and the MoE guidelines. Thereafter, the members agreed to approve the above mentioned list of eight (8) Adjunct Faculties for fresh appointments during Autumn 2021, for a period of three (3) years from the date of issue of the offer of appointment letter. The Senate further authorized the Chairman, Senate, to take the decision on selection of Adjunct Faculties for the other Departments, if required, and to present the selected list as a ratification item in the next Senate Meeting.

R3/SENATE-XXV/21: The Senate Resolved to Approve the list of eight Adjunct Faculties for fresh appointments during Autumn 2021 for a period of three (3) years from the date of issue of the offer of appointment letter. The Senate further authorized the Chairman, Senate, to take the decision on selection of Adjunct Faculties for the other Departments as well, if required and present the selected list for ratification.

### Item No.4: Proposal for Inclusion of Reservation Policy in Ph. D Admissions

The Senate was briefed that at NIT Meghalaya the Central Seat Reservation policy in admissions has not been applied for the Ph.D Programme and that the selection of the candidates are being done based on the eligibility criteria of the applicants, available faculties in a particular specialization and performance of the candidates in the written test/interview irrespective of their caste or gender. However, of late, the Institute has been receiving few queries in this regard and hence the view of the Senate was sought in this matter.

The matter was discussed but could not be resolved. The Senate therefore recommended analyzing the matter and presenting the proposal once again in the next Senate Meeting for further deliberation and appropriate decision.

<u>R4/SENATE-XXV/21</u>: The Senate **Recommended** to defer the proposal and present in the next Senate Meeting for deliberation and appropriate decision.

### Item No.5: Special Permission to Register for B. Tech Courses beyond 6 Years.

It was informed to the Senate that the following B. Tech students have completed the maximum duration of six years in the B. Tech Programme, but have not yet completed the course.

The recommendations of the respective Departmental Academic Committees along with the course completion plan to allow the students to extend the Programme by a year were placed before the Senate. The Senate discussed on the matter and approved one time extension of one year for the three students.

However, for one student, Onaldonie Wanbah (B15EE009), the Senate suggested that the DAC should provide a proper note for approval of the Chairman Senate, along with the subjects to be allotted to the student so that he can improve his CGPA beyond 5 credits. The Senate further authorised the Chairman, Senate, to take the decision on Onaldonie Wanbah (B15EE009) after the DAC submits a revised report and present the same as a ratification item in the next meeting.

R5/SENATE-XXV/21: The Senate Resolved to Approve one time extension of the Programme for the above students by a year from Autumn 2021 till Spring 2022. However, for student Onaldonie Wanbah (B15EE009), the Senate suggested that the DAC should provide a proper note for approval of the Chairman Senate, along with the subjects to be allotted to the student for improvement of his CGPA beyond 5 credits and it may be ratified in the next meeting.

### Item No.6: Special Permission to Extend Thesis Submission by a Year, beyond 8 years

Mr. Amal Dev Sarma, a part-time scholar joined the Ph.D Programme on 07-08-2013 in

the HSS Department of the Institute under the Supervision of Prof. Basav Roychoudhury, Professor (Information Systems & Analytics), IIM Shillong. He completed

the Ph.D Registration Seminar on 25-11-2015. He will be completing the maximum period of eight (8) years on 06-08-2021 but is yet to submit the thesis. The scholar had therefore forwarded an application, through his Supervisor and the DRC to allow him extension for thesis submission by an academic year, 2021-22.

It was briefed to the Senate that as per the Critical Dates mentioned in the Ph.D Regulations for Full Time/Sponsored/ Part Time Ph.D Programme, the maximum time for thesis submission is 8 years from the date of joining (R6(b)/SENATEXVI/18).

Considering the above points and after discussing at length, many suggestions were shared by the members. As it's the first time under Ph.D Programme that such a case was presented, it was also suggested to formulate a policy so that similar cases in future can be taken into account. In this context, the following points are listed as per the suggestions made during the meeting:

- 1) The scholar has to submit an application requesting for extension of duration, through the Supervisor.
- 2) The scholar should provide the progress details of his research work along with a plan for the completion of remaining work within the timeline.
- 3) As this case is requested with health issues, the scholar should provide a medical fitness certificate from an authorized doctor, stating that he is fit to take the remaining research work assignments. The recommendations of the Supervisor should be provided to the Chairman, DRC.
- 4) As the case falls under extension beyond 8 years, the chairman DRC may convene a meeting with the concerned DC to discuss the matter in light of the following:
  - I. Each semester progress report must be reviewed and checked whether any remark was made by DC in the progress during the period.
  - II. The DC may share their views of such progress in research work during the eight (8) years and how the scholar will complete the remaining research work along with thesis submission by fulfilling the minimum requirements, within the extension period.

The meeting minutes along with recommendations of DC should be forwarded to Dean (AA) and the details may be presented to the Senate for further analysis and appropriate decision.

**R6/SENATE-XXV/21:** The Senate **Recommended** to send the matter back to the DRC Chairman for analyzing the case in terms of the above suggestions provided by the members and to place the matter in the next Senate meeting for further analysis and appropriate decision. The Senate also recommended to formulate a policy to handle similar cases in future.

### Item No.7: Proposal for Amendment in the Ordinances

The Senate discussed about the amendment proposed in the Ph.D Regulations and confirmed the same.

### b) Inclusion of Programme Evaluation Committees (UGPEC & PGPEC) in the Ordinance

The Senate was briefed that the UGPEC & PGPEC are Programme Evaluation Committees functioning since the year 2018 with crucial academic responsibilities. It is hence proposed to include these Committees in the Academic Regulations with the following responsibilities and composition.

#### i) Responsibility:

The Committees shall analyze the examination results in respect of each course under the concerned Programme and provide suggestions to ensure fairness and transparency in grading before the declaration of semester results.

then his/her project work shall be evaluated by inviting the same external examiner and the result declaration should be made along with the Institute Summer Term/Special Exam Result which is notified in the Academic Calendar. The scholar may be permitted to receive the scholarship up-to the maximum period of 2 (two) years from the date of his joining the programme.

- ii) If the project is extended beyond1.5 months, then the scholar must register the same course by paying the semester fee. The project work shall be evaluated, and the result shall be processed to declare in the next semester. During this additional Semester, the student shall not be paid any scholarship.
- iii) If a student joins in a job before the completion of the project work, then the duration of the Programme may be extended by 1.5 times the remaining number of days or by a maximum of one semester upon approval of the Competent Authority.

The merit of above-mentioned cases was analyzed by DAC as well as the APC and the recommendations were placed before the Senate. The Senate after due deliberation on points i) to iii) above approved the proposal.

### b) Workflow of DC (role starts from Ph.D Registration Seminar till Defense of Ph.D Thesis)

The Doctoral Committee of a scholar is formed to monitor/review the progress of the research work carried out by the scholar. The DC has an important role starting from the registration seminar till the Oral Defense Examination.

The workflow of the Doctoral Committee during the period is proposed as follows:

- 1. If the research work carried by the scholar is satisfied during the presubmission seminar, the DC shall recommend for Thesis submission with a set of examiners (Indian and Foreign).
- 2. After receiving the reports from the thesis examiners, the Academic Section follows necessary process to take the approval from the Competent Authority. Upon approval, the reports are shared with DC.
- 3. The Supervisor shall convene a meeting with the DC members for analyzing the reports received from the examiners for any major or minor corrections as suggested or any other adverse recommendation. The meeting shall be minuted and the same should be shared with the Dean (AA). Based on the Thesis examination reports, the DC may specify the time-period required to revise the Thesis by the scholar.
- 4. Dean (AA) after receiving the minutes of DC, the necessary recommendations (if corrections/modifications raised by the DC based on the examiner reports) shall communicate to the concerned Supervisor. If there is no correction/modification required based on the recommendation of DC, the Supervisor may initiate the process for constitution of ODEC.
- 5. If the corrections/modifications are required as per the recommendation of DC, the Supervisor shall then communicate with the scholar to make the necessary corrections/modifications across the Thesis.
- 6. After the scholar submits the corrected thesis along with compliance report, the Supervisor shall convene another meeting with the DC members for further analysis and recommendation. Based on the recommendation of DC, the ODEC may be constituted for conducting Thesis Defense Examination.

The Senate discussed on the matter and the recommendations of the APC at length and approved the proposal.

**R8(d)/SENATE-XXV/21:** The Senate **Resolved** that the composition of the Doctoral Committee should remain as it is and **should not be altered as proposed**. The HoDs shall provide a panel of names to the Dean (AA) to nominate a member out of the list of names provided by the HoDs. The Dean (AA) will continue nominating the faculty member from other department/centre as Member 4 of the Doctoral Committee. The Senate further **Resolved to Approve** the workflow of the Doctoral Committee as presented.

#### Item No.9: Proposal on Implementation of NEP.

A Committee was constituted on the recommendations of the Competent Authority to draft the short-term and long-term plans of the Institute for the implementation of important features of the New Education Policy 2020. The Committee presented the following points for implementation upon approval of the Senate.

1. Interdisciplinary Courses

- 2. Multidisciplinary Projects
- 3. Skill Based Courses
  - a. Soft Skills
  - b. Technical skills
- 4. Long Term Internships

The Senate elaborately discussed on the above mentioned four points and suggested the following.

- 1) More than one course should be offered as Interdisciplinary Courses under Open Electives.
- 2) To implement the multidisciplinary projects by the UG & PG students, there should be two Supervisors from the parent branch and the branch offering the multidisciplinary projects.
- 3) The Skill Based Courses should be a compulsory audit course for the B. Tech students. If they pass, the same would be mentioned in the grade sheet/transcript. If they score below 5 CGPA, the same would not be mentioned in the grade sheet/transcript.
- 4) For Long Term Internships, the Senate insisted to implement the same from the next Academic Year. Further, it was recommended to present a detail plan in the next Senate meeting.

**R9/SENATE-XXV/21:** The Senate **Resolved to Approve** to implement the above mentioned proposed short-term plans under NEP from Autumn 2021 onwards.

### Item No.10: Online Exam Proposal under Prevailing Pandemic Situation.

It was briefed to the Senate that the Competent Authority had entrusted the responsibility of updating/modifying the online examination and evaluation patterns to the Internal Quality Assessment Committee (IQAC).

### Item No.11: Proposal to Offer Basis Yoga Course to the B. Tech Students

The Student Activity Center (SAC) of the Institute proposed to offer a physical class, "Basic Yoga Course", as an audit course to the B. Tech students of the Institute starting from Academic Session 2021-22 onwards, in order to achieve mental and physical fitness of the students through yoga awareness. The proposal for the course and the course content was presented to the Senate in detail by the SAC, President during the meeting.

The Senate appreciated the initiative to introduce a yoga course to the students with a suggestion that the Faculty Advisors of the students should also be made a part of the yoga course.

**R11/SENATE-XXV/21:** The Senate **Resolved to Approve** the inclusion of basic yoga course as an audit course for the B. Tech students from Autumn 2021 onwards.

### Item No.12: Ph.D Fee Structure for Candidates Selected through ICCR

It was briefed to the Senate that for the first time, a candidate who had applied for the Ph.D Programme of the Institute in the CE Department through ICCR has been provisionally selected for admission out of three applications received by the Institute this year. However, as this is the first time that a candidate applying through ICCR has been selected for the Ph.D Programme, the Programme In-charge of the Center for International Relations presented the proposed fee structure before the Senate for approval as under:

### Item No.14: Results of Spring Semester 2021 (except 2nd Semester B. Tech)

The Spring Semester 2021 Results (except 2nd Semester B. Tech of the students were declared on the scheduled dates with the approval of the Competent Authority. The results were presented during the meeting and the Senate accepted and ratified the Spring 2021 Results as presented.
