3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The programs have been granted accreditation for further 3 years. **National Institute of Technology Meghalaya, Bijni Complex, Laitumkhrah Shillong-793003, Meghalaya, India** should submit fresh online application under Tier I SAR January 2016 document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
