01. After evaluation of technical bids, financial bids of the successful bidders (technically qualified) will be opened on a later date which will be duly notified.

02. Submission of Compliance Certificate: Duly filled and signed Compliance Certificates (as per formats at Annexure-IA & B) are must with the technical bid.

03. Bid not transferable: The bid documents are not transferable and the seal and signature of the authorized official of the firms must appear on all the papers and envelopes submitted.

04. The quantity mentioned for each item in the Annexure-III may increase/decrease depending on requirements.

05. GST Registration Certificate should be closed along with the tender documents.

06. Relevant catalogue of the items (if any) must been closed.

## **Bidder's Eligibility Criteria**

1) The bidder should be a Private / Public Limited company registered under the Companies Act, 1956 or a registered firm.

2) Bidders should be in the business of Information Technology / System Integration for the last 10 years in India.

3) It is essential that the bidder should be able to provide support for next 03 years as per requirement of NIT Meghalaya. (The bidder must submit an affidavit confirming that the bidder will provide support within 3 working days during the warranty period.)

- The bidder must submit an affidavit confirming that the bidder has never been blacklisted in any Government Institutes/Organization or PSU.
- 5) The Bidder must possess a valid GST Registration Certificate, PAN Number. (Copy of the certificates to be submitted).
- 6) The Bidder shall not be under a Declaration of Ineligibility for corrupt or Fraudulent Practices with any Government departments/ agencies/ ministries or PSU's and should not be blacklisted as on submission of the NITM. A declaration by authorized signatory of the Bidder must be enclosed
- 7) The Bidder should be ISO 9001; ISO 27001 Certified

## Introduction on existing IT Infrastructure of Computer Centre NITM

NIT Meghalaya had implemented a mini data centre in the year 2014. This mini data centre was serving as a central data repository and research facility for students and faculties. At present the mini data center is not working as some of the hardwares is faulty.

## SCOPE OF WORK:

The Bidder shall require to install, configure and integrate the existing mini data centre (HPCOE). The installation and integration shall be done by OEM certified Engineer

The details are mentioned below:

- The Bidder must register and update all the firmware of all the hardware to latest.
- The Bidder shall make the existing mini data centre setup up and running.
- The renewed setup/repair work/solution shall include the complete installation and commissioning cost and any additional hardware/accessories/licenses/software cost required in order to make the system up and running.
- The Bidder must install, configure and integrate complete setup as per requirement of NIT Meghalaya.

## INSTALLATION & WARRANTY SUPPORT

- Vendors must furnish the guidelines for installation/configuration of hardware and software before the start of the project.
- Installation and integration and customization will take place at NIT Meghalaya No remote access will be provided for the same.

- The warranty of the hardware & software is 3 years from the date of installation and activation of the software. It covers the free upgradation of software, troubleshooting with OEM support and subscription.
- Warranty shall not become void even if NIT Meghalaya buys any other supplemental hardware from a third party and installs it within these machines. However, the warranty of the OEM will not apply to such hardware items installed. If the bidder is not the OEM for the brand quoted, the warranty for the hardware / software shall be provided from the OEM.

At the time of installation of the systems/subsystems, if it is found that some additional HW/SW/Licenses items are required to complete the configuration, which were not included in the vendor's original list of deliverables, then the vendor is required to supply such items to ensure the completeness at no extra cost to NIT Meghalaya.

Note: Vague terms like "packing, forwarding, transportation etc. extra" without mentioning the specific amount will not be accepted. Such offers shall be treated as incomplete and rejected.

01. **Quotations have to be submitted in Indian Rupees only**. If goods are to be imported, the quotations shall include all charges for customs clearance, clearing agent fees, landing port handling charges, insurance etc. and onward transportation of the goods from the port/airport of landing for door delivery upto NIT Meghalaya, Shillong, Meghalaya.

NIT Meghalaya has a valid registration with the Department of Scientific and Industrial Research (DSIR), Ministry of Science & Technology, Government of India for availing Customs/Central Excise Duty exemption. NIT Meghalaya will provide all necessary certificates, authorizations and documents required for clearing the consignment and for onward transportation upto Shillong.

- 02. All documents submitted should be digitally signed by the bidder.
- 03. Bidder must unconditionally accept all terms and conditions stipulated in the tender document and all pages of the bid including all enclosures must be duly filled in and digitally signed by the bidder or his authorized representative.
- 04. The bidder must also upload a digitally signed copy of the **Tender Acceptance Letter** in the format given at Annexure-IV.
- 05. Validity of Quotation: Quoted rates must be valid for 90 days from the date of quotation.
- **06. Warranty: The quoted equipment and components** must be warranted for a minimum of **three (03)** years from the date of successful installation and training.
- 07. Literature must: All the quotations must be supported by the printed technical data sheet/ literature and

the specifications mentioned in the quotation must be reflected/ supported by such printed technical datasheet/ literature. The model no. and specifications quoted should invariably be highlighted in the datasheets/literature for easy reference.

- **08.** Details of supply of similar items to Institutes of National Importance/universities/organizations etc. (preferably those located in the Northeastern region) must be provided along with the technical bids.
- 09. **Presentation:** Technically qualified bidders may be called upon to give full presentation of the quoted equipment at NIT Meghalaya campus before opening of Price bid as a support of their Technical Quotations and for any clarifications.
- 10. Equipment breakdown: Any Equipment breakdown must be attended to within **7 days** during the warranty period of the equipment free of cost.
- 11. **Training:** Free training is to be provided to NIT Meghalaya personnel on the operation, installation, training, maintenance and troubleshooting of the supplied items.
- 12. After Sales Service: Vendor should clearly state the available nearest after sales service facilities in the Northeastern/eastern region, without which the offer will be rejected.
- 13. **Dealership Certificate:** The bidder/tenderer should be either a manufacturer or authorized agent of the foreign/Indian manufacturer. Dealers or Agents quoting on behalf of Manufacturer must enclose valid dealership certificate.
- 14. **EMD:** Earnest Money: Refundable earnest money deposit (EMD) of ₹ 33,000/- (Rupees Thirty Three Thousand) only through demand draft drawn (of any Nationalized/Scheduled Bank) in favour of National Institute of Technology Meghalaya, payable at Shillong, will have to accompany the technical Bid. The EMD of unsuccessful bidders shall be returned without any interest after award of contract. EMD of the successful bidder will be released without interest on submission of the Performance Bank Guarantee or delivery of the ordered items, as applicable.

Firms registered under MSME will be exempted from submitting EMD. In case of firms registered under NSIC, exemption will be given to the permissible extent, as indicated in their Certificate. All vendors claiming exemption must submit copies of their valid MSME/NSIC registration Certificate (along with the Technical Bid in case of two bid system). Offers received without Earnest Money or valid Certificate shall be summarily rejected.

- 15. **Performance Bank Guarantee (PBG):** The successful bidder shall furnish an unconditional PBG (asper format at Annexure II) for 3% of the Purchase Order value from a Nationalized/Scheduled Bank of India, before release of the payment. Else 3% of the billed amount will be deducted as security deposit. Where the PBG is obtained by a foreign bank, it shall be endorsed by a Nationalized/Scheduled Indian bank and shall be governed by Indian Laws and be subject to the jurisdiction of courts at Shillong. The PBG shall guarantee that,
  - The Vendor guarantees satisfactory operation of the Equipment & components against poor workmanship, bad quality of materials used, faulty designs and poor performance.
  - The Vendor shall, at his own cost, rectify the defects/replace the items supplied, for defects identified during the period of guarantee/warranty.

The PBG shall remain valid for period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.

- 16. The vendor should have Income Tax account (PAN), GST Registration Certificate.
- 17. The item(s) will be used only for research purpose of the Institute and not for any commercial use. Hence, vendors may quote concessional rate of IGST @ 5%. Relevant documents shall be provided by the Institute.
- 18. Training should be provided by the bidder till the satisfaction of the users on free of cost.
- **19.** The bidder should mention about the utilities required for the setup.
- 20. The RF anechoic chamber must be installed within the space provided by the NIT Meghalaya.
- 21. Delivery:
  - a. Time Limit: Maximum within 60 (Sixty) days from the date of issue of purchase order.

- b. Safe Delivery: All aspects of safe delivery shall be the exclusive responsibility of the vendor. At the destination site, the package will be opened only in the presence of NIT user/representative and vendor's representative. The intact condition of the package and the seal/indicators for not being tempered with, shall form the basis for certifying the receipt in good condition.
- c. Insurance: The supplier is to establish 'All Risk Transit Insurance' coverage till door delivery at Computer Center, NIT Meghalaya, Shillong Campus.
- d. Part Delivery: As far as possible no part delivery shall be entertained. However, in extreme cases, acceptance of part delivery shall be a prerogative of the Institute.
- e. Penalty for delay in delivery: The date of delivery should be strictly adhered to otherwise, the Director, NIT Meghalaya reserves the right not to accept delivery in part or full. The Director, NIT Meghalaya also reserves the right to impose penalty, as deemed fit, for delay in delivery of the equipment, including imposition of Liquidated Damages (LD). The decision of the Director shall be final and binding to all.
- 22. **Genuine Pricing:** Vendor is to ensure that quoted price for the particular item is not more than the price quoted to any other customer in India, particularly to IITs/NITs and other Government Organization. Copy of the latest price list for the quoted item, applicable in India, must be enclosed with the offer.
- 23. **Conditional tenders not acceptable:** All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Conditions mentioned in the tender bids submitted by vendors will not be binding on NIT Meghalaya.
- 24. Late and delayed tender: Late and delayed tender will not be considered.
- 25. Payment: 100% payment within 30 days from of successful installation commissioning and acceptance.
- 26. Payment will be made through PFMS. Bidders are required to furnish complete and correct bank details on their letterhead along with the technical bid. A scanned copy of a cancelled cheque may also be attached for verification of IFSC code.
- 27. Enquiry during the course of evaluation not allowed: After opening the Technical Bid, no enquiry from the bidder(s) shall be entertained during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s). However, the Purchase Committee or its authorized representative may make enquiries/seek clarification from the bidders. In such a case, the bidder must extend full co-operation. The bidders may also be asked to arrange demonstration of the offered items, in a short period of notice.
- 28. At any time prior to the date of submission of bid, NIT Meghalaya may, for any reason, either of its own or in response to a clarification from a prospective bidder, modify the bidding documents by an amendment / corrigendum. Any such amendment / corrigendum will be duly notified through the Institute's website only and CPP Portal. Prospective bidders are advised to check the Institute's website every now and then for any amendment / corrigendum. In order to provide reasonable time to take the amendment into account in preparing the bid, NIT Meghalaya shall extend the date and time for submission of bids.
- 29. The acceptance of the quotation will rest solely with the Director, NIT Meghalaya, who in the interest of the Institute is not bound to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all the quotations received without assigning any reasons.

## **30. Force Majeure:**

If the performance of the obligation of either party is rendered commercially impossible by any of the events hereafter mentioned that party shall be under no obligation to perform the agreement under order after giving notice of 15 days from the date of such an event in writing to the other party, and the events referred to are as follows:

- (a) Any law, statute or ordinance, order action or regulations of the Government of India,
- (b) Any kind of natural disaster, and
- (c) Strikes, acts of the Public enemy, war, insurrections, riots, lockouts, sabotage.

#### 31. Termination for default: Default is said to have occurred

- (a) If the equipment or any of its component is found having poor workmanship, faulty designs, poor performance and bad quality of materials used.
- (b) If the supplier fails to deliver any or all the services within the time period(s) specified in the purchase order or any extension thereof granted by NIT Meghalaya.
- (c) If the supplier fails to perform any other obligation(s)under the contract.

Under the above circumstances NIT Meghalaya may terminate the contract / purchase order in whole or in part and forfeit the EMD/PBG as applicable. In addition to above, NIT Meghalaya may at its discretion also take the following actions: NIT Meghalaya may procure, upon such terms and in such manner, as it deems appropriate, goods similar to the undelivered items/products and the defaulting supplier shall be liable to compensate NIT Meghalaya for any extra expenditure involved towards goods and services obtained.

#### 33. Applicable Law:

- a. The contract shall be governed by the laws and procedures established by Govt. of India and subject to exclusive jurisdiction of Competent Court and Forum in Shillong /India only.
- b. Any dispute arising out of this purchase shall be referred to the Director, NIT Meghalaya, and if either of the parties here to is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties, to be appointed by the Directorof the Institute. The decision of such Arbitrator shall be final and binding on both the parties.

## 34. Site Visit:

The bidder is recommended to visit the mini data center before participating in the tendering process. The visit should be informed to the computer center in-charge well in advance. A confirmation email will be sent to the bidder upon request.
