IMPORTANT INSTRUCTIONS FOR THE CANDIDATES

- 1. The Skill/ Trade Test will be held on the 26th July, 2023 in the concerned Department/ Centre, NIT Meghalaya, Bijni Complex, Laitumkhrah, Shillong 793003.
- 2. The candidates must first report at the Administrative Block, NIT Meghalaya, Bijni Complex, Laitumkhrah, Shillong 793003 at 09:30 AM for verification of their documents.
- 3. After document verification, the candidates shall proceed to the concerned Departments/ Centres for the Skill/ Trade Test.
- 4. The Tests shall tentatively commence from 10:30 AM onwards.
- 5. You are required to bring with you, the following documents for verification/ submission:
 - a) All certificates /proof of date of birth/caste certificate/experience certificate, etc. and mark-sheets, in original, commencing from High School (i.e., class 10th).
 - b) Proof that you belong to Schedule Caste (SC), Schedule Tribe (ST) and OBC category, if claimed by you; OBC candidates shortlisted for Skill/ Trade Test must produce the latest OBC certificate which should not be older than 6 months from the date of the advertisement. Candidates failing to produce the certificate as instructed will be summarily rejected and will not be allowed to appear for the Test.
 - c) If you are in service with any Government Organisation/ Autonomous Bodies/ Corporation/ Statutory Bodies, etc, "No Objection Certificate" (NOC), from your present employer (or a copy of the forwarding letter in case your application was duly forwarded through proper channel) is required. Document in support/proof of experience and salary drawn.
 - d) Candidates not producing the original certificates or providing false certificates shall not be permitted for the Skill/ Trade Test.

 - (c) Any other similar valid reasons.
