Terms and conditions:-

- 1. Detailed particulars containing schedule of items can be downloaded from the Institute website: www.nitm.ac.in
- 2. Vendor/Supplier should quote their rates in the enclosed schedule only (Annexure-I).
- 3. Rates to be quoted by the bidder should be inclusive of all taxes, duties, freight and insurance charges, and any incidental charges at F.O.R. **NIT Meghalaya, Permanent Campus, Saitsohpen,Sohra**.
- 4. Vendor/Supplier shall be liable to supply the water in time as and when required by the Institute on receipt of order either in writing or telephonic (including Saturday & Sunday).
- 5. The Bill shall be paid on monthly basis as per the number of trips/water supplied in litres recorded in the Register/Log Book and due verification by the Institute officials.
- 6. The accepted rate should be valid for 18 (Eighteen) months from the date of issue of Purchase Order.
- 7. The Tender shall be received & opened on the next working day, in case the date stipulated for receipt & opening of Tender in this NIT is declared a Holiday / non working day.
- 8. The bidder should invariably indicate their complete Postal address including Pin code, mobile/phone number, name of the work, clearly on the envelope containing their quotations.
- 9. Termination of Contract: On expiry of period given in the contract. Further, the contract can be terminated at any time during the currency of the contract on the grounds of unsatisfactory performance established on the part of the vendor or any such material complaints. The contract can be terminated at any time by giving a Notice of one month in advance from either party.
- 10. Arbitration: Disputes, if any, shall be settled mutually; failing which, it shall be referred to a One-Man Arbitrator to be appointed by Director, NIT Meghalaya in accordance with the Arbitration and Conciliation Act 1966, whose decision shall be final and binding on both the parties.
- 11. The Institute reserves the right not necessarily to accept the rate of the lowest bidder and may reject any or all the quotations without assigning any reason thereof.
