ORDER


(No.C&S.3/2009/PT.III/155, Dated Shillong, the 11th February, 2022)

In pursuance to the order of Home (Political) Department, Government of Meghalaya vide No.POL.75/2020/PtI/122 dated 11.02.2022, in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 do hereby order the following in East Khasi Hills District with immediate effect till further orders:-

1. Night Curfew will be lifted with immediate effect in East Khasi Hills District.
2. Private transport within East Khasi Hills will ply on **Odd-Even** number basis as per earlier Notification. This excludes **Two Wheeler Vehicles.**
3. Only fully vaccinated persons are permitted entry to restaurants/cinema halls/ bars/clubs, etc. It shall be the responsibility of the proprietor/owner to ensure that all visitors are doubly vaccinated.
4. Gatherings/ Events /Weddings are permitted subject to prior permission from the Deputy Commissioner and adherence to Covid appropriate behaviour.
5. Shops are permitted to open on Sundays.
6. All persons should follow Covid appropriate behaviour including wearing of masks in public places and maintaining social distancing.

In view of the urgency of the matter this Order has been made ex parte.
