2. The training in each discipline/subject shall be for **300 Hrs OR may be decided by the institute as per the requirement raised by SP with mutual agreement** at the time of contact.
3. The institute shall provide infrastructure like auditorium, seminar halls, internet facility, photocopy machine, attendant and team of faculty for coordination.
4. **The training shall be conducted as per the schedule convenient to the institute for pre-final year students** (the final schedule would be decided at the time of contract).
5. The cost should be quoted in Indian Rupees only.

9. The service provider shall be responsible for conducting different tests like Benchmarking test, tests for each module etc.
10. Each module must be supported by online/offline assessment module.
11. The last date of submission of offer is **14/09/2018 by 01PM.**
12. The representatives of SPs may present on the ***date of opening sealed quotations i.e. September 14, 2018 2:00 PM to 04:30 PM.***

15. The least cost would be evaluated on the basis of Total Cost Per Student (Last column).
16. The Institute will consider those quotations to be substantially responsive which are properly signed and conforms to the terms and conditions, and requirement as per the Term of References (TORs).
17. Award of contract: The institute will award the contract to the SP who has offered the lowest cost.
18. The SP whose offer is accepted will be notified of the award of contract by the institute prior to expiration of the quotation validity period.
19. The SP shall have to sign the contract with purchaser which will contain the terms and conditions of the accepted offer. The Service provider shall provide detailed schedule of breakup for each of the appropriate modules covering the different skills in the contract document.
20. The SP should attach a detailed chart of experts mapped according to the course of GATE syllabus supported with bio-data of experts would be engaged to cover different modules.
